- ✦ **ALCOHOLIC BEVERAGES ARE NOT ALLOWED ON THE BUS DURING THE TRIP**
- ✦ **“Creditable Express, LLC”** driver and/or employee reserves the right to refuse any individual(s) whom they deem to be disruptive, intoxicated, to pose a safety threat to themselves or to others, or deemed to be using an illegal substance.
- ✦ **“Creditable Express, LLC”** is not responsible for underage consumption of alcoholic beverages at any time before, during, or after the ride. Driver has the right to inspect Id's & containers of passengers who appear underage.
- ✦ For any actions such as fighting, violence, damage to equipment and/or bus, harassment toward the driver, staff or anyone else in or around **“Creditable Express, LLC”**, the driver reserves the right to terminate the trip. The client will be responsible to find other transportation and forfeits full fare as a result.
- ✦ By signing up for and participating in the ride, the individual agrees that **“Creditable Express, LLC”** and its employees are not responsible for any claims for injuries, loss, damage, death, liability, criminal or civil litigation for the participating individual arising out of or relating to a ride.
- ✦ By signing this contract, the above client agrees to assume full responsibility for any damages to the interior or exterior of the bus that is caused by any individual riding in the bus. The client is liable for the cost to repair any such damage as well as any cost for loss of **“Creditable Express, LLC”** service due to such damage.
- ✦ **“Creditable Express, LLC”** is not responsible for injuries or accidents in and around the bus. Alcohol impairs motor skills, balance and judgment. Clients are asked to remain seated while the bus is in motion. Move about your own risk. Please use caution on steps and hand rails.
- ✦ **“Creditable Express, LLC”** is **NOT LIABLE** in cases of accidents, severe weather or anything that may delay a timely arrival or cause cancellation of the trip. In the event of a cancellation due to mechanical problems, the trip may be rescheduled for another date. Client will be notified as soon as possible to let them know of unexpected problems that may postpone trip times.
